

# Campus candidate application and hiring process

## How to apply

# Hiring process for campus candidates

During the recruitment process, you'll be asked to complete an application for employment. You'll first want to visit the EY student job board where you'll find all open job opportunities. You can utilize the filters to navigate by country, city\*, service line\*\* and start date. Please apply for the one position in which you are most interested, and no more than two positions within a six-month period.

After you apply, we'll review your application, résumé, and qualifications. Students are selected for interviews based on academic background, extracurricular activities, and work experience. If you are selected, you'll be invited to participate in the interview process, which in most cases is virtual. This is a great way for us to get to know you, understand your career interests and qualifications, and evaluate your potential role at EY US.

A decision is usually made within a few weeks of the final interview. We know that waiting to hear can be tough – so we will let you know as soon as we can. Our recruiters and professionals will stay in touch with you throughout the recruiting process, and we ask that you do the same. We welcome you to ask questions, request additional information or let us know if you have received another offer.

### Hiring process for students

#### **Explore EY**

Interviews Selected candidates will be invited to participate in the interview process, which in most cases is virtual.

We aim to make offer decisions within a few weeks of final interviews. An update will be provided as soon as possible.
