G. William Andrews, Chief Executive Officer

Mr. Andrews joined Campbell & Company in April 1997 and was appointed Chief Executive Officer in October 2012. He served as Co-Director of Research from November 2011 to October 2012 and Chief Operating Officer from January 2010 to May 2012. During his tenure at Campbell, Mr. Andrews also held the positions of Vice President and Director of Operations, Vice President and Director of Research Operations, and Research Assistant. Mr. Andrews has served on the firm's Investment Committee since 2010. Prior to joining Campbell, he was employed at Legg Mason as a Research Analyst in the Realty Group from November 1995 to April 1997. Before immigrating to the United States, he was employed by the Japanese Department of Education in the town of Fujimi, Nagano prefecture. Mr. Andrews holds an M.B.A. in Finance from Loyola College in Maryland and a Bachelor of Social Science from Waikato University, New Zealand.

Mr. Harris joined Campbell & Company in July 2000 and was appointed President in October 2012. Mr. Harris formerly held the positions of Deputy Manager of Trading in 2004, Director of Trading in 2006, and was appointed to the firm's Investment Committee in March 2010. Mr. Harris was also elected to the Board of Directors in 2012. He previously worked as a futures and options broker for Refco Inc.
