### 2) Model UN

# **Description:**

Continued from previous request (02/14/12)

The org is asking for an addition to last week's request, therefore voting was reopened.

Changes:

Additional funding is being requested because the tax policy does not stand in New York; also, the dean is not giving the group the contribution that was originally expected.

### Questions

Sam: The dean wont fund more, yet you still only want the previous cost?

A: I know that others want to do so as well.

Kian: If this is not funded, are you sure that you'd be able to fund the event?

A: I sent an email out to everyone saying that we might have to pay an additional 100-150 if we are not funded. They sound positive about it, but they are hoping for \$100

#### **Discussion:**

Damani: We do ask them to go back on the organization, and I appreciate her going back and doing that. I feel the same way that I did about this last time.

Kaylesh: I feel like the cost per person still is kinda high. I'm definitely fine with doing the original, because I feel like the cost per person was reasonable.

Kian: Can we use the student activity fee to fund the tax.

Michelle: If it's out of date, then yes. If it's in state, then no.

Michelle: {Note: does straw poll {2 for, rest against}. For those against, are you all against partially funding? How much of the taxes are you willing to fund?

Kian: Given the content of the event and something that is this long, I'll be comfortable with funding half of this price.

Sam: I agree with around half. If we can take some of the pressure off of the organization members then I think that will help a lot.

Kaylesh: I still think that \$90 per person is a lot. That's like the cost of the student activity fee and in the past, we have rejected people for less.

Damani: We've pretty much said yes to the original. For me, I recognize it as expensive, but the overall value of the actual event swayed me to pay for it. The event itself is worth the intended price.

Morgan: Same reasoning. The higher price is well worth what we've been saving by not funding student conferences.

Kian: I recognize that this is not a one day or two day conference; this is a five day conference in NYC. I know it's a good idea. I'm comfortable with funding less, but not less than half.

Sara: Think about past conferences, did you only decide to not fund it because it was a cost of the student activity fee or more?

Kaylesh: There is a definite structure and it's longer than the other conferences that I've seen.

Sara: Well, TSA, did you reject it because of the cost or the content?

Kian: If we're going by the activity fee, we can't validate it given the cost per person. I want to fund this, because it's a valuable event. With all the departmental support that they have and the scale of the event, it's hard to compare to two.

Ebony: Out of all the conferences, this is actually something directly related to their org. I think we don't have to fund the whole thing, because they can actually do it. They have the option open to partially funding and that's fine as well.

Michelle: So you're saying the original price is what you support?

A: I don't think that is appropriate. The students have already paid \$300.

Ebony: So the members have already paid out of pocket?

A: We have ways to offset the cost should you give us the funding, but then we'll have them pay \$100 along with the \$300 already paid.

David: Every request that you're given, you have to go by the standard that you set for all the organizations. If you have a standard, then it gives you a bar to set for all future request. When you think about how many individuals can pay, you'll sacrifice thinking about the actual merit of the event.

Damani: I recognize now that this is expensive. I feel that the additional price incurred in tax based on the quality of bringing "backness" does suffice. It is expensive, but we don't want to use this arbitrary number. If we can come, then it'd be fine, but I'd still be fine funding the additional amount.

{Note: Finance Board moved to other groups and then came back to Model UN}

Michelle: For the four opposed, are you still opposed?

Kaylesh: I still feel like this is expensive, because it's how I was evaluating these conferences.

Ebony: Based on what David said, I'm going for the full amount.

Kian: If we're talking student activity fee...I think spending \$90/person on a five day conference is different than a one day one. It's different from one where someone sits all day and eats pretzels, than a competition in NY. I can't justify paying that amount for any conference, at this point I don't now how comfortable I am with this.

Kian: After some thought, I'm for fully funding it. But what is the measurement? it makes me wonder what is valuable to everyone. Since I can't answer that, do we not like that measure? WE say that we're comfortable for funding \$90 per person and there's a lot to it, than just the numbers.

Damani: I'm comfortable with funding it. It's very valuable.

Morgan: I'm for fully funding it for what it can bring back. It brings back what the student activity fee is worth.

Sam: I'm leaning towards fully funding. I would prefer to fund it, but the precedent that it sets is a little dangerous. I would rather fully fund it than not funding it at all.

Kaylesh: I think I struggle when it comes to conferences, but I think one of my main things was about how much we say no to conferences and I want to make sure that students have the opportunities to bring things to the campus.

Ebony: I'm for fully funding it just because of the quality of it; can't place a number on it.

Sam: The allocation request does not match up with the actual planning form.

Sam: Why did you move it to the skylight room?

A; A lot of the spaces were filled up and we didn't want to risk the rain.

Damani: Can you walk me through the event?

A: We want to have it similar to the past. The performers will open the dance floor to dancing. The theme and food and décor with go within the theme.

Sam: I have two questions, do you have breakdowns for food and quotes?

A: Yes {reads out breakdown}

Sam: Second question, on your allocation request, you have entertainment for 300, are you still having performers?

A: We will, but performers within UMBC. Originally we were going to get people from outside, but changed our minds.

Kian: Do you have anything more specific for the decorations?

A: Not right now.

Damani: How many people would you be expecting?

A: About 140 people.

# Description

# **Questions:**

Sam: Can you walk me through your event?

A: We'll have the audience to be sitting around the table that the dance groups will be using as well.

*Kaylesh: Can you clarify the purpose of the uniforms?* 

A: We wear leotards when we dance; we can't really reuse them for hygienic purposes.

*Kaylesh: Did you get money for the ones worn last year?* 

A: Yes

Kaylesh: Can you explain the uniforms for the organization?

A: We use uniforms because as a Christian organization, it's important that we cover ourselves. And it's less because we did ask old members to return their uniforms (at least the ones that can be shared).

Sam: Do you have quotes for your food and decorations?

A: {reads quotes}

### Discussion

Kian: It sounds fun. I don't see anything wrong with it, but I might be missing something.

Sam: I like this event. At first I looked at uniforms, and I was a bit skeptical, but it seems that it's like a tool they need.

Kaylesh: If they're an open organization, then okay. I'm fine with uniforms as long as they try to reuse them.

# Description

## **Questions:**

Michelle: We saw a request about just the coffeehouse, did things change?

A: We're actually having two so they invited us to come join with them to make it fair trade.

Kian: Is this something that would require a quote for our rule?

Ebony: Giant is a well-known business with a set price. We would need quotes for small businesses whose prices are more variable.

Kian: So total with possible discount?

A: We put it in with the request.

Sam: When we added this up, we didn't get the same numbers.

A: We have to see if it's {the discount} possible, because it's only for k-12 schools and non-profits. If you add up the totals.

Sam: I'm getting a total of 43.13 and the grand total also doesn't match.

Kian: For the documentary, did you get special permission for that?

A: We're working with a non-profit who has the documentary.

Sam: For advertising, what is the purpose of the laminated fill mountain poster? What does this add?

A: Because the poster will guide the people through the event, and it's 7 different schools working on the same thing.

Morgan: So how is the tent structured? I know a tent is small.

A: They would go straight through and the posters will surround them as if leading them through.

Michelle: Do you have a back-up plan in case of inclement weather?

A: We're going to speak to the commons to see if they have any covers.

#### Discussion

Damani: The laminated posters are actually apart of the tent. I don't see it as an advertisement, but rather, a more of an expensive material. I don't see it apart of the marketing package.

Sam: For the flyers, SGA gives student orgs 1000 free copies, but it's going to be black and white and not recycled paper; if you do that then you can use that instead to lower the price.

Kaylesh: I consider the \$798 as essential for the quality of the event. It's the total cost.
