- Intro to ORCID iD and ORCID record
- Benefits of ORCID:
  - Your ORCID iD distinguishes you from others
  - Your ORCID iD persists over time
  - Your ORCID record can bolster your digital identity
  - Your ORCID record can save you time when you have to fill out forms
- ORCID in the research landscape (Why it's important to keep your ORCID record info up to date):
  - Funders are asking for or requiring ORCID iDs
  - Publishers asking for or requiring ORCID iDs
  - Research institutions are also using ORCID
  - ORCID usage varies between organizations, so look for the ORCID iD icon so you can:
    - Sign into systems using ORCID
    - Import info from ORCID - pre-filling forms
    - Send info to ORCID - keep everything in one place (enter once, re-use often)
- How info gets added to your ORCID record:
  - manually yourself
  - manually trusted individual
  - search & link
  - automatically via trusted organizations
- Tips for updating ORCID records:
  - Works - Search & Link, DOIs - Crossref & DataCite, BibTex import (BibTex export)
  - Funding - Search & Link
  - Affiliations - use dropdown
    - Employment
    - Education
    - Qualifications
    - Invited positions
    - Distinctions
    - Membership
    - Service
  - Peer Review - If your peer review process asks you for an ORCID iD, they may be able to add your peer review information to your ORCID record for you. Or, you can try using Web of Science - Publons.
  - Biographical info - alternate names, email addresses, keywords, bio, etc. - helps to distinguish you even more.
- Look for the ORCID icon - use your ORCID iD and ORCID data whenever possible!
