- Her focus: Enhance processes, reach out to campus partners

Campus wide training in August 2025

- o Internal training: All of her staff are now procurement certified by the state
- Questions for her
 - Does she have a full staff? The department lost one grant contractor and will start interviews for a replacement soon.
 - Will there be more campus wide audit meetings? Sharon, who is in daily communication with MAS says not at this time. (One of our folks observed that campus needs to be aware that we are regularly audited, and they need to be compliant with policy and procedures.)
 - Do some departments have trouble approving p-card reconciliations due to other workload? Departments are responsible for deciding who their approvers are. If there are problems getting monthly reconciliations approved, please let Procurement know.
 - How is the new Meal Policy going? The revised draft is still circulating, must go through MAS and/or general counsel.
 - What is the most common p-card credit limit? The most common credit limit is \$5K. Requests to raise someone's credit limit must be approved by GAD at the state.
- Questions for us: what are our challenges in this area?
 - Faculty doesn't know procedures, breaks rules
 - We don't know how to contact Procurement
 - Look at their website to determine your area's staff member
