Information from our first quarterly meeting with Lynne Adams, Chief Human Resources Officer, Helena, Barbara and Terisa

- We should expect to receive a letter about our promised salary increases no later than September 19. The increases will be retroactive to July 1, and we should see this retro pay in our September 26 paycheck.
- HRSTM will review all NESS-eligible positions to ensure that they are classified correctly (exempt, non-exempt bargaining employee, or non-exempt confidential employee).
 Reviews will need an updated position description (PD). Here is a link to the current template if we want to start filling one out for ourselves. Supervisors should also be able to provide a PD, and some PDs are part of the regular PMP process.
- USM is expected to review all non-exempt positions separately from our HRSTM department.
- We're starting to see executive coordinator positions on campus, sometimes replacing
 executive assistant (EA) positions. Executive coordinator is an exempt position, often
 including supervisory duties and extra responsibilities. Could this possibly be a career
 path for EAs? Lynne will look into this but, if the executive coordinator position requires
 a bachelor's degree, that may restrict some folks from moving into that role.
- Professional development opportunities for confidential employees? Helena will meet with Jill Wardell and Melody Wright to explore this.
- Shadowing programs in HR, finance, payroll, etc? Lynne will look into this.
- The PeopleSoft system will be enhanced so that we'll more easily be able to see our own pay scale.
- Please let Helena know if you have questions that the team can bring to Lynne at their next meeting.
