ERICA ANTILL works as an Environmental Scientist at URS Corporation, and is on the NEPA/Natural Resources Team within the Sustainability and Environmental Management Group. Her responsibilities include planning and performing fieldwork, evaluating data, researching a variety of environmental topics, and writing reports. She received her M.S. in Geography and Environmental Systems from UMBC in 2011 and has a B.S. in Biology from the University of Massachusetts, Amherst.

STEPHANIE BERTAINA is a Senior Policy Analyst with the U.S. Environmental Protection Agency's Office of Sustainable Communities in Washington, D.C. In this role, Stephanie conducts policy research on local, state, and federal policies that support smart growth, and provides technical assistance to states and communities across the country that are seeking to implement more sustainable approaches to development. After college, he traveled and taught English in Europe for a year, worked in a physics lab at the University of California, Los Angeles for another year, and then came back to Maryland to teach math at UMCP. While teaching math, he became familiar with Mike Tidwell and CCAN, through Mike's books and open houses as well as volunteer opportunities on CCAN's campaigns. Those experiences inspired Tommy to seek out work as a climate activist.
