The Maryland Art Place (MAP) Board of Trustees, Out of Order Host Committee and Program Advisory Committee are eager to invite you to exhibit your artwork as part of the 25th Annual Out of Order Benefit Exhibition and Silent Auction on Friday, April 22, 2022. Out of Order (OOO) attracts upwards 250 artists each year and is a unique opportunity to exhibit your work, meet area patrons while supporting one of Baltimore's most established contemporary arts organizations.
